FEDERAL COALITION GOVERNMENT'S CHANGES TO INDEXATION

The TASS Executive has welcomed the news that following the recent election of the Federal Coalition Government, it has announced changes to the indexation for superannuants receiving Commonwealth Government defined pensions.

Some 57,000 military superannuants, whose pensions are currently indexed to the consumer price index (CPI) can soon look forward to a pension which will be indexed in the same way as social security Age pensions thereby, according to the new government, **providing fairness and easing the pressure on their cost of living**.

Indexing of state and commonwealth superannuation pensions by CPI began in 1973, based on the principle of maintaining the pension's purchasing power. However, since the early 1990's this is no longer the case. The Australian Bureau of Statistics has stated that the CPI has failed to keep pace with the rising living costs of Australian households.

Former Liberal Prime Minister John Howard acknowledged this by adjusting the CPI indexation of the Age pension to the better of CPI and MTAWE (Mean Total Average Weekly Earnings) stating that this allowed recipients to share in the rising living standards of the community.

The Federal Coalition has also promised that it will index Commonwealth Seniors Health Card (CSHC) eligibility. The CSHC was introduced in 1994, and is available to people who are of pension age, but do not qualify for the Age pension. The eligibility is means tested and taxable income thresholds apply.

Ironically, the indexation of this threshold will only apply to people on untaxed-sourced pensions, such as those receiving a defined benefit pension. People on taxed-source pensions do not have those pensions taken into account for the CSHC eligibility, as they have little or no taxable income.

SUCCESSFUL MEMBERS FINANCIAL FORUM

The 35 members who attended the Financial Forum in Hobart in September acclaimed it as a great success. Presenter, Scott Donoghue, provided members with a most informative and entertaining presentation of up to date financial information.

Scott covered a range of financial topics:

Superannuation:

- Changes that Mysuper has made to retirees incomes;
- awareness of movements in the share market to maxaimise returns;
- allocations in portfolios that may provide the best options for TASS retirees;
- awareness of changing fee structures in portfolio options;
- life pensions as against allocated pensions;
- account-based pensions;
- estate planning options;
- daily unit pricing; and
- understanding the introduction of switching fees.

Centrelink:

- Current levels of eligibility for full, or part-time pensions;
- income tests eligibility; and
- the effects of superannuation in regard to wills and beneficiaries.

Financial Planning:

- Choosing financial planners verification of their qualifications; and
- alternative investment options.

At the conclusion of the Forum, TASS president Murray Harper congratulated Scott on his excellent adddress and presented him with some quality Tasmanian wines in appreciation of his contribution on behalf of the members attending, followed by afternoon tea.

The Executive welcomes TASS members in the North and North-West to take the opportunity to attend the <u>Forum in Launceston on Tuesday 3 December</u>, which will not only provide wonderful financial information, but also the chance to socialise with fellow TASS members at morning tea and the included buffet luncheon.

TASS EXECUTIVE ACTION

The members of the TASS Executive meet every month at which the standard meeting procedures are observed and minuted by the secretary. However, much of the work of TASS is continued on an ongoing basis between meetings by our two subcommittees:

- The **Lobby & Liaison** subcommittee, convened by the president, Murray Harper, which continues the task of maintaining our campaign of indexation equity with the State Government, along with our relationships with kindred organisations, both within Tasmania, and at the national level.
- The **Member Activities & Promotion** subcommittee, convened by Kip Muller, which arranges member activities, such as the AGM, member luncheons and activities (eg. the financial forums.)
 - This subcommittee is also responsible for the compilation and publishing of the newsletter *Super-News*, along with all promotional material, such as the TASS membership brochure.

As TASS does not have a specific physical office location, all work undertaken by the Executive is carried out at our own private residences, apart from the monthly meeting which is held at a venue in central Hobart

Most of our communication with each other is done by telephone, email or by letter - as several members of the Executive do not have computers.

Our residences are also spread around Hobart, from Austins Ferry in the north to Richmond, Midway Point and Acton Park in the east, Lauderdale in the south-east and Blackmans Bay in the south.

During the current year we have undertaken the following activities:

- approved the Tasmanian Association of State Superannuants Inc. as an incorporated organisation;
- approved and published a revised (2013) Constitution of the Tasmanian Association of State Superannuants Inc. which is now available on the TASS website;
- actively pursuing the indexation campaign which was debated in State Parliament in March;
- held an inaugural luncheon with North and North-West TASS members in Devonport;
- organised a Financial Forum for members in Hobart and another Forum in Launceston for members in the North and North-West;
- convened a one day workshop to identify key actions that the Executive continues to address on behalf of our members throughout the year, (such as developing contacts with current public sector employees who are eligible to become members of TASS, by liaising with the relevant public sector unions);
- established a formal process of communication with the Retirement Benefits Fund;
- established a process for communicating by email with TASS members online; and
- continued to improve the TASS brand image in updating our stationery and the Website.

Through *Super-News* and the TASS Website we will continue to keep members aware of actions undertaken by the Executive.

TASS HEALTH

- with Dr Jane Tolman, Director of Aged Care Services, Department of Health and Human Services

This is the final article in the series from Dr Jane Tolman entitled, 'HOW TO AGE WELL'.

PHYSICAL HEALTH

The big lesson of successful ageing is that as we grow older there is less reserve. What we can get away when we are younger catches up with us later. Every single little thing that we can fix before it becomes a big problem should be given attention. Not becoming physically unwell is obviously the best. This means the adoption of good health habits and regular screening, such as:

- bowel;
- breast and prostate cancer;
- vision and hearing checks; and
- blood pressure monitoring.

Remember that regulation of blood pressure is the most important factor in reducing the chance of stroke, but hypertension may be asymptomatic. Only half of older people know their blood pressure and only a third are treated to currently recommended levels. Get checked every time you go to your doctor and know the level. Be aware of your cholesterol levels. Vaccinations have proven benefit. It means taking tablets prescribed appropriately.

When you develop an acute illness, don't delay treatment. If you have a chronic illness, make sure you are up to date with information, and know where you stand. Be aware of the prognosis and what you can do to minimise complications or deterioration. Be vigilant with your treatment.

We certainly are not able to guarantee a successful ageing. But by starting early, and being vigilant, we have the power to improve our prospects of doing well. Optimism and happiness go hand in hand. Happy people have a higher self esteem, are more in control and are more optimistic. They are more emotionally self aware, less self absorbed, less hostile and abusive, and have better people skills. Happy people are less resilient to illness, and are less likely to die prematurely.

Being positive and cultivating a happy outlook will assist in promoting a healthy and fulfilling old age.

I have enjoyed the simpler functions in which I have engaged in the worlds of commerce and politics after the higher levels of ethics, responsibility dedication in education.

Since retirement, my jobs selling real estate, pies, sickness disability insurance and taxi trips revived the instinct for sales and service I acquired as a child selling old newspapers to greengrocers for fourpence a pound and working in my grandparents' newsagency and the Shoe Mart managed by my father.

Remembering my mother's frequent admonition to a bored child: "Get something useful to do!", when I lost my 22-month hold on one of the State Franklin seats in March 2010, I resolved to become, once again, useful to fellow citizens by resuming cab driving. I have found my mobile social life in a cab fascinating. Through the pages of Super-News I will provide in future editions readers with vignettes from the world of a cabbie.

IMPORTANT INFORMATION FOR TASS MEMBERS

RBF LIFE PENSION ANNUAL DECLARATION

In response to queries from TASS members the Executive has received the following information from the Retirement Benefits Fund (RBF) regarding the annual collection of information on RBF member status.

RBF Regulation 136 provides the Retirement Benefits Fund with the power to seek information to assist in establishing ongoing benefit entitlement.

The power to withhold payment of a benefit where RBF has reasonable doubt as to whether an entitlement should be paid is provided by Regulation137.

RBF has periodically required all life pensioners to complete a declaration, formally known as a Life Certificate, which verifies important personal detail and assists in ongoing benefit entitlement.

This process has recently recommenced and going forward it is expected that all Life Pension recipients will receive these forms annually, and these will be issued in the month after the pensioner's birth month.

LATE NEWS!

In the last edition of *Super-News* (No: 3/13 September 2013) we detailed the disappointing response from the State Government in developing an Actuarial report into the indexation of our superannuation pensions without any input from TASS. Greens Leader, Nick McKim wrote to Scott Bacon, Minister for Treasury and Finance to further pursue the matter. However, Mr Bacon's reply maintained the Government's position that no further action would be considered at this time.

With the Tasmanian State election due in March next year, the TASS Executive will continue to seek the views of each of the political parties in regard to the indexation issue.
