SUCCESSFUL TASS MEMBERS FORUM

A Members Forum was held at Hadleys Hotel, Hobart on 7 October.

Dr Bruce Felmingham, Principal of Bruce Felmingham Economic Consulting addressed the gathering and presented a series of slides in which he outlined the current status of financial issues facing independent retirees such as TASS members, following the outcomes of both the federal and state budgets.

The presentation included an overview of the changing financial landscape and the impacts on superannuation of these changes, some of which may affect TASS members depending on their individual circumstances such as:

- Pension incomes included in calculations for the Commonwealth Seniors Health Card (CSHC);
- the Age pension thresholds to be fixed for three years from 2017;
- the Age pension entitlement age to increase to 70 from 2035;
- raising the preservation age to access superannuation entitlements;
- changes to the deeming rules for Account Based Pensions from 1 January 2015.

The Tasmanian Government has agreed to maintain pensioner concessions and rebates despite the loss of federal funding for this purpose. They have been fully funded in the 2014-15 state Budget.

A number of options for a more equitable method of indexation of the RBF Pension other than the current Consumer Price Index (CPI) model were canvassed, including the preferred Male Total Average Weekly Earnings (MTAWE). A table of the indexation outcomes relating to the options canvassed demonstrated the disadvantage of the CPI formula. It was suggested that as CPI is a formula by which the Australian Bureau if Statistics sets the CPI figure, perhaps TASS and related organisations could refocus the measure to one taking into account the general "well-being" of retirees. The point was made that any reference to the total unfunded liability of state service pensions should not be quoted as a total impost on government, but rather the cost as a line item in the annual state budget. Perhaps TASS could seek advice on the legal status of unfunded liabilities and the status of the current arrangements.

Dr Felmingham explained that the loss of GDP to the Australian economy through the ageing of the population has a 1.7% effect on the annual growth rate. As Australians age, their expenditure shifts to another set of products more appropriate to their lifestyle and changing family and work commitments. He also made the point that governments were more interested in assets rather than income and that this was likely to continue in the future.

An important but underrated issue is the value of unpaid work such as voluntary work and whether this is factored into the economy. This is an important aspect of the overall economy and should be considered in any discussion of an ageing population and its potential burden as people are living longer and there are up to five generations within some family units.

A number of other issues affecting the ongoing role of TASS and its commitment to members were raised by Dr Felmingham, and also by members attending the Forum as follows:

- TASS should actively pursue potential members from those still working in the state service as we are the specific organisation representing their interests in retirement. Currently, TASS has 106 members who live interstate, and 4 overseas in New Zealand, England and Ireland.
- The TASS website has now been updated with a new layout which will be continuously updated for members. It contains a' Feedback Form' for members to contact and submit issues of interest for other members, as well as provide comment or information to the Executive.
- It is proposed that a 'Members Views' page be included in *Super-News* for members to also provide the same opportunity to comment on issues of interest to them in print form.
- *Super-News* is now available for members to receive electronically for those with access to email and they have the option of receiving it by this means rather than by post.
- TASS should request members to forward copies of *Super-News* to other friends and colleagues currently still employed in the state service to encourage them to join TASS, particularly those about to retire.
- Dr Felmingham suggested that *Super-News* could run a series of member 'case studies' featuring issues of common interest to all TASS members.

Afternoon tea was served at the conclusion of the Forum.

IMPORTANT INFORMATION FOR ALL TASS MEMBERS!

This important information provided to TASS by the RBF was received on the day that this issue of *Super-News* went to press. Members should read this statement in respect to their own individual financial circumstances.

AN UPDATE FROM THE RETIREMENT BENEFITS FUND (RBF)

The Tasmanian Government's Strategic Review of the future direction of RBF continues to progress. The aim of the review is to identify options for the most appropriate way to manage public sector superannuation into the future.

Stage 2 of the review involved the preparation of a report by PricewaterhouseCoopers, which was commissioned by the former Labor - Green Government, and which has been received by the Liberal Government.

Subsequent to receiving the report, the Treasurer asked RBF to enter into discussions with Tasplan and Quadrant and then report back to him with options for consideration by the Government. The three funds provided a joint submission to the Treasurer in late September 2014.

The Treasurer has stated any decisions will be made in the best interests of members and will not affect members' legislated entitlements.

The Government has indicated it hopes to make a final decision by the end of 2014.

RBF has sought advice from the Commonwealth Department of Social Services and from the superannuation industry associations regarding changes to Centrelink deeming rules in the context of mergers of superannuation funds.

RBF understands that this issue is currently the subject of a draft Bill which was released for consultation by Federal Treasury on 23 September 2014. That Bill proposes that involuntary transfers of accounts resulting from a merger of superannuation funds should not result in the holders of those accounts being disadvantaged under the applicable tax legislation.

RBF will continue to monitor this situation and keep our members informed via our website www.rbf.com.au once the legislative position is clearer. If you would like to discuss any of the above information, please contact RBF via the RBF Helpline on 1800 622 631

TASS PEOPLE

Through the pages of Super-News we have the opportunity to learn about the contribution that many of our members have made during their lives and careers within the Tasmanian community. Robyn Cromarty OAM is one such member. This is Robyn's contribution in her own words.

My community work started in 1939 when I was a child entertainer at Brighton Army Camp. My parents Jack and Caroline Allen voluntarily catered and served supper once a week and I played the piano to entertain. One particular night I remember the 2/40th soldiers singing: "When the roll is called up yonder I'll be there". They sailed two days later and many died.

During the war I knitted dozens of pairs of socks and mittens for the troops overseas. When I was 16 I was nominated as "Victory Girl" representing Green Ponds Municipality, and with the help of my parents and a small committee raised 537 pounds for the Australian Comforts Fund.

In 1950, with Government approval, the Post Master General's Department extended a telephone service to the remote farming district of Hunting Ground with the exchange to be operated from my parents convict-built home "Mauriceton". My Dad said I had nothing to do but round up the sheep and help my mother, so I could easily work the exchange. I was offered three shillings and sixpence (35 cents) per week (40) hours when a telephonists pay was nine pounds a week. Mr Gil Duthie referred to it in Parliament as "slave labour". In the 13 years I operated the exchange I was never paid more than two pounds 15 shillings per week.

The old open wires would often cross and I would walk miles to uncross them with a fishing rod to save the linesmen travelling. Once, a fault was reported on the line at the same place and time for four days. When the linesmen investigated I received the verbal report: "we found Foster's bull scratching his backside against the pole causing the wires to cross".

On leaving Hunting Ground I was offered a temporary position of two years at Claremont Post Office. This stretched to 27 years including 10 as Postmistress. I was awarded the OAM in 1995 for service to the community.

My husband was William Cromarty, a former engineer officer with the Port Line, and until his death in 1976 he worked on the permanent staff of the Hydro Electric Commission. We had three children and I now have five grandchildren. I am happy to have made friends in TASS.
